#### a) Athletes Commission

#### **c) World Championships**

- 2014 Veterans World Championships: the candidature of Port-Louis (MRI) was confirmed.

A call for candidatures will be done during the 2013 Congress for the following World Championships:

- 2015, 2016, 2017 J/C
- 2016 Teams
- 2017 Seniors
- 2015, 2016 Veterans

As for the 2015 J/C World Championships, if the candidatures permit it, the 2013 Congress will be asked to vote on awarding these championships in order for the chosen federation to start the needed preparations.
